— Exclusive Economic Zone (EEZ) — Territorial Sea (TS)

Ireland's marine waters measure 490,000km² (approx. 7 times its terrestrial landmass) and comprise parts of the Irish and Celtic Seas and the Atlantic Ocean.

It sets out the Irish Government's vision, high-level goals, and key 'enabling' actions to put in place the appropriate policy, governance and business climate to enable Ireland's marine potential to be realised. Ireland has completed the initial assessment of its marine waters, established targets and indicators, established a monitoring programme and submitted its programme of measures to the European Commission.
